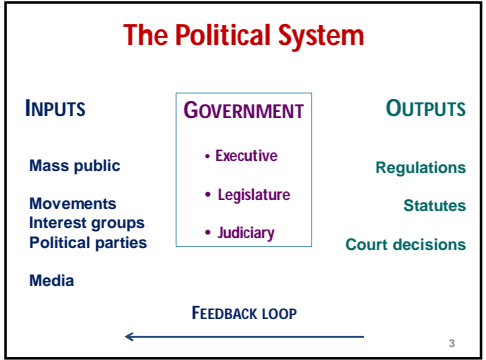

Abramowitz & Fiorina agree about the definition of political elites:

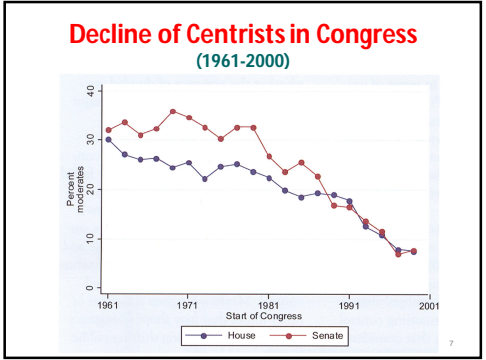
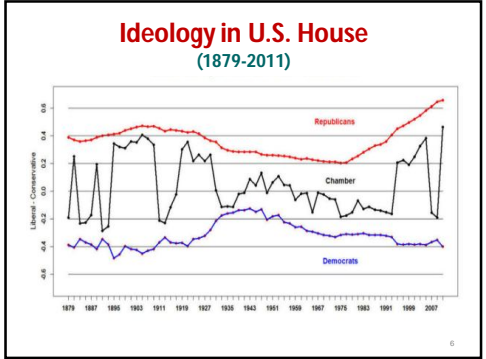
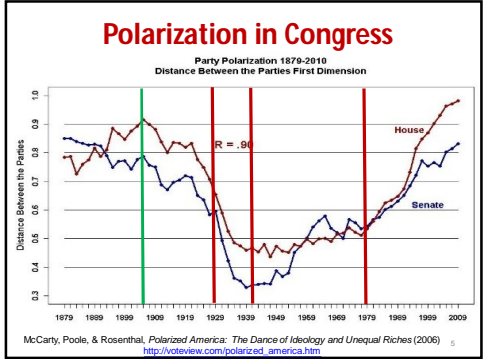
- 1) Elected & appointment office-holders inside government

Abramowitz & Fiorina also agree about the nature contemporary political elites:

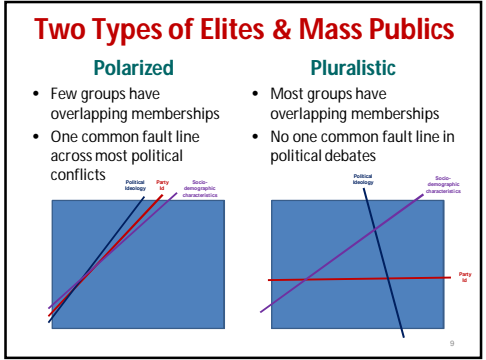
- 1) Ideologically polarized
- 2) And, therefore dysfunctional

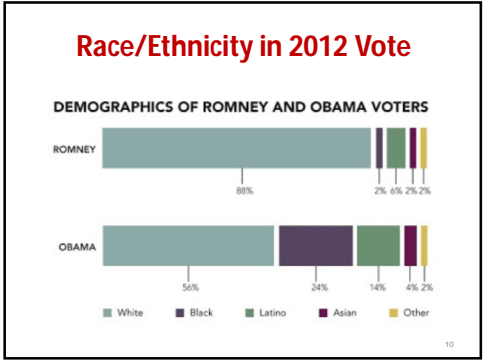


The Current Debate (Part III)

Abramowitz & Fiorina disagree about what causes elite polarization:

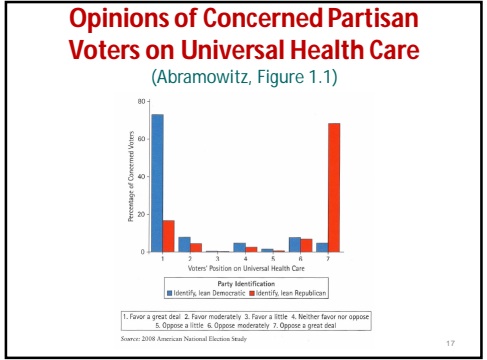
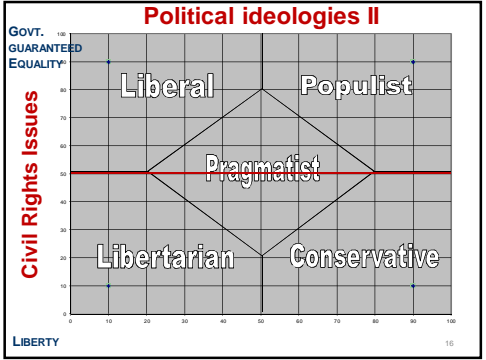
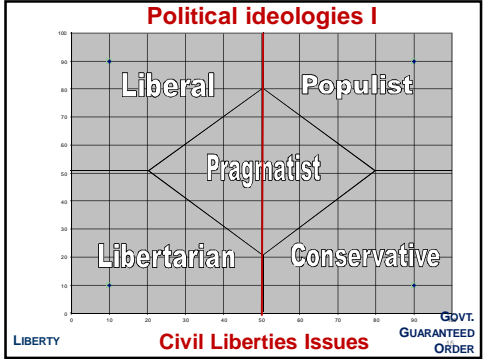
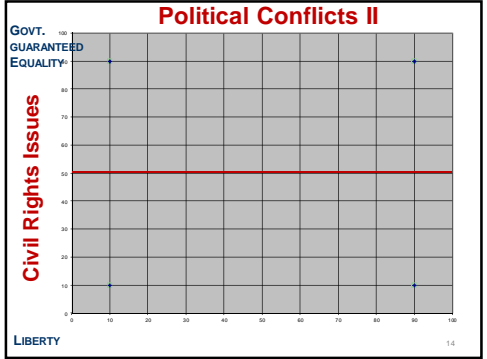
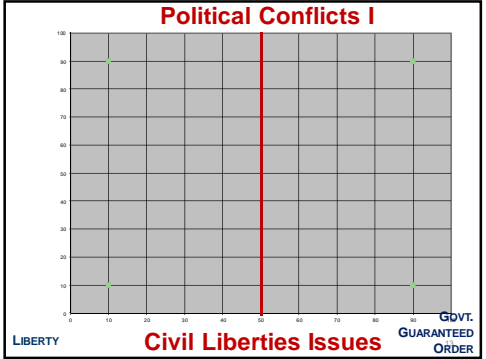
- **Abramowitz:** polarization in elites is mainly caused by polarization in the mass public
- **Fiorina:** the mass public is
 - more pluralistic than polarized
 - highly cynical about dysfunctional political elites





- ### Madison's Core Assumptions
- Human nature
 - Often flawed by self-interest, haste, passion, and short-sightedness
 - True of even the "best and the brightest" in both the mass public and elites
 - The best public policy comes from:
 - Bargaining and compromise between competing interests
 - Rarely does one side have a monopoly on wisdom and virtue
 - Compromise will happen more easily and often if both elites and masses are pluralistic rather than polarized

- Individual liberty versus government-guaranteed order
 - Economic
 - Social
 - Individual liberty versus government-guaranteed equality
 - Economic
 - Social
