Interventions Strategies in Alcohol and Drug Problems (Psych 551); required graduate level course with numerous assignments, papers and out of classroom experiences for about 7 graduate students per semester. I developed this course in 1996. It is the capstone course for the SATP master's concentration in Psychology.

Advanced Psychopathology (Psych 547): required graduate level course for SATP Graduate students, elective for General Concentration Graduate Students. Covers all of Abnormal Psychology including diagnosis with the DSM and introduction to Assessment. I developed and was the first to teach this course in 1994. Generally 8 – 10 Graduate students

Psychology Graduate Practicum: Providing weekly clinical supervision for two advanced level graduate students on clinical assignments in the SATP Concentration

Psychology Graduate Internship Supervision: provide clinical supervision one hour per week for one or two SATP graduate students completing their required six month internship (supervision is ongoing, regardless of when academic semesters begin and end, so it continues through the summer and semester breaks)

Research Seminar (Under various names), Psych 495: Research and supervision of work by undergraduate students including presentations and papers.(taught every semester, usually 10 – 12 students per semester)

Theories of Counseling in Substance Abuse (Psych 492): upper level undergraduate course, which I developed and taught for the first time in Spring, 2000 Requires intensive class participation, an essay midterm and final, and a project for the class related to treatment of substance abuse
