# STATE OF NORTH-CAROLINA NEW HANOVER COUNTY

WHEREAS, complaint upon oath hath this day been made to us, two of the Justices of the Peace of the aforesaid County, by Hezekiah Bonham, that a certain male slave named FRANK, to him belonging, about twenty-four years of age, dark complected, about six feet high, hath absented himself from his said master's service for a considerable time, and is lurking about said County committing acts of felony and other misdeeds; these are therefore in the name of the State to command said slave Frank forthwith to surrender himself and return home to his said master; and we do hereby, by virtue of the Act of the General Assembly of the State aforesaid, in such cases made and provided, intimate and declare that if the said slave above named does not surrender himself and return home immediately after the publication of the presents, that any person may kill and destroy the said slave by such means as may be used or thought proper, without accusation or impeachment of any crime or offence for so doing, and without incurring any penalty or forfeiture thereby. M.W. CAMPBELL and JOHN MACCOLL, Esq'rs, two of the Justices of the Peace in and for said County. WHEREAS, complaint hath this day been made to us two of the Justices of the Peace of the said county, in ROBERT W. BROWN, of the said county, (merchant) that a certain male slave, belonging to him, named CUPID, hath absconded himself from his said master's service, and is lurking about in the said county committing acts of felony and other misdeeds.

These are therefore, in the name of the State, to command the said slave forthwith to surrender himself and return home to his said master. And we do hereby also require the Sheriff of the said county of New Hanover, to make diligent search and pursuit after the said slave; and him having found to apprehend and secure so that he may be conveyed to his said master, or otherwise discharged as the law directs. And the said Sheriff is hereby authorised and empowered, to raise and take with him such power of this county as he shall think fit, for apprehending the said slave. And we do hereby, by virtue of the act of Assembly in such case provided, intimate and declare, that if the said slave named CUPID, doth not surrender himself and return home immediately after the publication of these presents, that any person may kill and destroy, the said slave, by such means as he or they may think fit; without accusation or impeachment of any crime or offence for so doing, and without incurring any penalty and forfeiture thereby.
